

## CPAC UPDATE OCTOBER 9, 2020

Welcome to the Community Performance and Art Center. Below is a list of protocols and policies to prepare you for your experience attending CPAC performances this year. Ongoing adjustments and decisions will be made following recommendations from state and local officials.

- In compliance with Pima County resolution 2020-49, all guests and staff are required to wear a mask while at CPAC (inside or outside)
- Previous seat assignments may need to be adjusted to allow for increased distancing
- Seating is limited to 50% theater capacity
- Concerts may be moved to the outdoor patio when weather and circumstances permit
- The house will be opened 20 minutes prior to curtain
- Tickets must be purchased prior to the performance as sales will not be available at the door
- All tickets are automatically emailed but also available at will call 30 minutes prior to curtain
- Patrons must issue a specific request to have season tickets printed
- All events will be conducted without intermission or concession service
- Patrons may move to an empty seat if it provides increased distance from surrounding guests
- Patrons will exit the venue one row at a time, front to back, by using the nearest exit
- CPAC follows state cleaning protocols: sanitizing stands are stationed throughout the venue
- Remember to wear a face cover, wash your hands frequently, stay home if you are sick, and practice social distancing whenever possible

\* While we will be making our best effort to ensure a clean and safe environment, it is impossible to eliminate all risks of infection. Please consider your own individual circumstance and make the decision that is in your best interest, even if it means staying home.

In light of COVID-19, we are committed to offering a No-Risk Guarantee for all ticket purchases to our 2020-2021 season. In the event that your event is canceled, or you are not able to attend, please contact the office prior to the performance time and you may obtain credit for a future performance, receive a full refund or consider donating your ticket back to CPAC as a tax-deductible gift.
