



"Structures" CPAC ART SHOW 2023

CPAC is pleased to announce a visual art exhibition: **Structures**. The website <https://www.vocabulary.com/dictionary> defines and describes structures as something of many parts that is put together."

"Structure is from the Latin word *structura* which means 'a fitting together, building.' Although it's certainly used to describe buildings, it can do more than that. A family's structure includes the relationship of its members, your body structure can refer to how your muscles and bones fit together." Other structures can be bridges, dams, houses, spider webs, trees, shells, organizations, etc.

Arizona artists are invited to participate in this juried exhibition at CPAC. Each artist can submit up to three pieces. Submissions are welcome from across the spectrum of visual arts. The entry fee is \$30. All artworks must be for sale. CPAC will retain 25% of the sale & handle the paperwork. Please remember this as you price your work on your entry form. **Artists agree to pay CPAC their 25% commission on any work displayed during the exhibit that is sold within 30 days after take-down of the show.**

Prizes: First Place - \$300, Second Place - \$200, Third Place - \$100, Three Honorable Mentions

Juror/Judge: Fran Sutherland, an award-winning artist and teacher, Fran Sutherland earned her BS and MS degrees at the State University of New York at New Paltz, NY. In addition, to her continued career as an art instructor, Fran has worked as graphic, theater, interior, and architectural designer as well as a historic restoration consultant. Many of her works, including *The Bridge Series*, integrate geologic coloration and the play of light and water with local and international sites and architectural structures. Sutherland's semi-autobiographical paintings continue to be inspired by New York's Hudson Valley and Arizona's Santa Rita Mountains.

She is a member of the Arts Society of Kingston (ASK) Kingston, NY, Woodstock Art Association and Museum (WAAM), Woodstock, NY, Tubac Center of the Arts, and the Santa Rita Art League (SRAL), Green Valley, AZ. View works by Fran at <http://www.fransutherland.com/>.

ARTWORK ELIGIBILITY

Arizona artists are invited to submit up to 3 individual pieces, provided that they meet the following requirements:

- All work must be original, designed and created by the applicant
- Two-dimensional submissions:
 - Only gallery-wrapped canvas with a 1½ inch-depth, or artwork mounted on a cradle board with a 1½ inch-depth will be accepted without being properly framed.
 - The entire assemblage should not exceed 20 lbs in weight

- Size - no more than 9 sq. ft. e. g., 30" x 40"
- All work must be designed as a wall hanging and ready to hang
 - Hanging hardware shall consist of stranded or coated wire passed twice through screw eyes and twisted at least eight times.
 - The screw eyes or D-hooks should be approximately 1/3 down from the top of the artwork, and the wire 2-4" from the top of the artwork when stretched taught.
- If the artwork surface is fragile (e.g., a watercolor, pastel, charcoal), it must have a glass or acrylic (e.g., Plexiglas) cover.
- Artwork must be dry and odor free
- All work must be available for display for the full duration of the exhibit.
- Due to the sensitivities that must be considered in a public environment, CPAC reserves the right to refuse the display of any display materials that contain obscenity, nudity, religious, mythological and/or metaphysical symbolism or pieces that may impose a threat of physical harm to patrons.

GENERAL INFORMATION

- Application due with checks made out to CPAC by March 24, 2023. (Address is on the attached Entry Form)
- Include a biography and/or artist statement with application to be displayed in a notebook during the exhibition.
- Work to be received in CPAC's gallery on Friday, March 31st from 10:00 AM – 11:00 AM.
- Jurying and judging will take place on Friday, March 31st from 12:00 – 2:00 PM
- Notification of acceptance of work will take place from 2:00 – 3:00 PM on March 31st via e-mail. (Phone calls will only be made to artists who do not have an e-mail address).
- Artwork delivered to CPAC that was not selected for the exhibit should be picked up at CPAC in the gallery lobby on March 31st from 3:00 – 4:00 PM

- Reception on Saturday, April 1st from 5:30 PM – 7:00 PM.
- Artwork will be taken down on Monday, May 1st from 9:00 AM – 10:00 AM.
